The following are the benefits to FSIC membership;

- A set of brochures, posters and fridge thermometers will be mailed to the representative – only members will receive mailed material

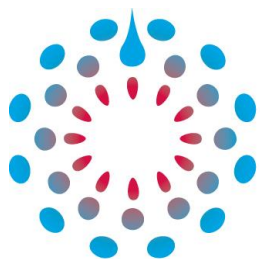
Annual membership fees are due on the 1 July each year and are to be paid on invoice (14 day terms) from FSIC. You can join at any time.
